

Licensing Agreement

made as of _____
between Cycorp, Inc. (“Licensor”)

1. Definitions

- 1.1. “Authorized User” means, if Licensee is an organization, an employee, faculty member, staff member, or student officially affiliated with Licensee and authorized by Licensee to use Software. If Licensee is an individual person, the “Authorized User” means Licensee.
- 1.2. “Software” means text files and machine-readable object code versions of ResearchCyc® Axioms, documentation, and code, as may be distributed by Licensor from time to time for use by Licensee.
- 1.3. “Cyc® Axiom” means any logical formula, rule, link or assertion in the Software, including any translation of such axiom into any other language (including but not limited to KIF, Ontolingua, GFP, LOOM, PowerLOOM, CGs, CycL, MELD, C, C++, IDL, predicate logic, and English) and any logically equivalent rearrangement or renaming of its components, terms, or variables.
- 1.4. “Confidential Information” shall mean the Software, all aspects of the design and operation of the Software, and any other information provided by Licensor to Licensee that is identified as confidential at the time of disclosure by Licensor. “Confidential Information” excludes the information identified in Section 4.4.
- 1.5. “Copyright Act” refers to United States Copyright Act, Title 17 United States Code § 101 et. seq.

2. License

- 2.1 Licensor hereby grants Licensee a nonexclusive, nontransferable, royalty-free license, without the right to sublicense, under Cycorp copyrights, to:
 - (a) Install the Software on a computer owned or leased by Licensee, perform regular backups of the Software (with customary professional standards of care in handling backed up files), and make the Software accessible over a network only to Authorized Users; and
 - (b) Use and execute the Software only for testing, debugging, validation, research, development and maintenance purposes.
- 2.2 Licensee shall not rent, lease, lend or give the Software without the prior written consent of Licensor. Licensee shall not use the Software to process accounts or records or

documents or to generate output data for the direct benefit of, or for purposes of rendering services to, any individual, any other business entity, or any other organization, other than as authorized above, except that Licensee may use the Software in research projects funded by external parties for the purposes set forth herein.

- 2.3 Nothing in this license should be construed as limiting Licensee from producing novel representations of facts or claims about the world, even if those facts or claims happen to be represented by information contained in the Software, so long as those representations do not constitute derivative works, and so long as they are neither translations of nor otherwise derived from substantial portions of Software.
- 2.4 Nothing in this license shall be construed as limiting Licensee from producing and/or distributing software designed to be used in conjunction with licensed copies of ResearchCyc.
- 2.5 Licensor shall have no obligation under this Agreement to correct any bugs, defects or errors in the Software or otherwise to support or maintain the software.

3. Proprietary Protection

Licensee agrees that Licensor owns all rights, title and interest, including but not limited to patent, trade secret, and all other intellectual property rights, in the Software and any changes, modifications or corrections to the Software made by Licensor. The license granted herein is not a sale of the Software and Licensee shall only receive title to the media and copy of the Software delivered hereunder. Licensee shall not attempt to reverse engineer, reverse assemble, reverse compile, de-compile or make any use whatsoever of the Software in any attempt to derive a replacement for the Software, nor will Licensee allow anyone else to do so. Licensee recognizes that the Software, and elements thereof, constitute valuable trade secrets and other property of Licensor; and that Licensor's rights in and to the Software are protected by copyright and other laws of the United States and other countries; and that the unauthorized use or disclosure of Confidential Information by Licensee may cause damage to Licensor, who may seek injunctive and other relief as permitted by law; and that the marks "Cycorp," "Cyc," "ResearchCyc," "OpenCyc" and "CycL" are trademarks of Licensor

4. Limitations on Use and Disclosure

- 4.1. Licensee agrees to use reasonable care to maintain the Confidential Information in confidence, and to prevent the unauthorized use, disclosure, or availability of any of the Confidential Information; access is limited to Authorized Users, except that Licensee may freely discuss any of the Confidential Information with others known to be legitimate licensees of the Software.
- 4.2. Licensee may use small portions of Software within academic and instructional publications and presentations so long as such usage constitutes "fair use" under the Copyright Act. Licensee shall not remove or destroy any proprietary markings or attribution information placed upon or contained within the Software.
- 4.3. LICENSEE WILL NOT INCORPORATE ANY CONFIDENTIAL INFORMATION INTO ANY LICENSEE PRODUCTS OR EXTERNAL SERVICES.
- 4.4. For purposes of this Agreement, "Confidential Information" shall not include, and the obligations herein shall not apply to, information that: (a) Is now, or subsequently is

made, generally available for use by the public under a license from Licensor; or (b) That Licensee can demonstrate was rightfully in its possession prior to disclosure to Licensee by Licensor; or (c) was disclosed by the Licensor to a third party free of any duty of confidentiality on the third party; or (d) was disclosed under operation of law or court order provided the Licensee uses reasonable efforts to give the Licensor prompt notice prior to such disclosure and cooperates, to the extent permitted by applicable law, with the Licensor in its efforts to keep the Confidential Information confidential. This paragraph must not be construed as granting a license less restrictive than any other license under which the Licensee has access to the Confidential Information.

5. Term of License

The term of this Agreement and the license granted hereunder shall be from the date first set forth above until the earlier of: (a) one (1) year after the effective date of the Agreement, (b) receipt of notice to terminate sent by Licensee to Licensor, (c) sale or acquisition of Licensee to a third party, (d) breach of this Agreement by Licensee, (e) replacement by a superceding agreement. The limitations on use and disclosure detailed in Section 4, above, shall survive any termination of this Agreement.

6. Disclaimer of Warranty

6.1 LICENSEE ACKNOWLEDGES AND UNDERSTANDS THAT IT IS RECEIVING AND WILL BE USING SOFTWARE THAT IS NOT A FULLY TESTED PRODUCT OFFERING, HAS NOT BEEN COMPLETED ACCORDING TO LICENSOR'S NORMAL DEVELOPMENT PROCEDURES, AND WHICH MAY CONTAIN ERRORS, OMISSIONS AND PROBLEMS. EXCEPT AS EXPRESSLY STATED IN THIS AGREEMENT, LICENSOR DISCLAIMS ANY AND ALL EXPRESS AND IMPLIED WARRANTIES WITH RESPECT TO THE SOFTWARE, AND WITH RESPECT TO ANY SERVICES PROVIDED HEREUNDER, BY ANY PERSON OR ENTITY INCLUDING SPECIFICALLY THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. THE SOFTWARE IS PROVIDED "AS IS" AND "WITH ALL FAULTS" AND LICENSEE UNDERSTANDS THAT IT ASSUMES ALL RISK OF ITS USE, QUALITY AND PERFORMANCE. IN NO EVENT SHALL LICENSOR BE RESPONSIBLE FOR ANY SPECIAL, CONSEQUENTIAL, ACTUAL OR OTHER DAMAGES, REGARDLESS OF TYPE, OR ANY LOST PROFIT RESULTING FROM USE OF THE SOFTWARE.

6.2 The entire risk of use and consequences of the use, both direct and indirect, of the Software shall be on the party using it. Licensor shall not be liable in any respect for any claims for loss or injury alleged to have resulted from any use of or reliance on the Software or any part thereof by Licensee, by any customer of Licensee, or by any other person. Licensee hereby agrees to indemnify, and does hereby indemnify, Licensor against any and all claims which may arise directly or indirectly out of the use or operation of the Software by Licensee or any customer of Licensee. Licensee shall be responsible for verifying the accuracy of results produced using the Software. Licensee shall be responsible for following proper backup procedures for any other programming and all data to protect against loss or error resulting from use of any or all of the Software.

7. Limitation of Liability

LICENSOR ASSUMES NO RESPONSIBILITY WITH RESPECT TO USE OF THE SOFTWARE OR DOCUMENTATION, OR ANY OF THE SERVICES PERFORMED BY LICENSOR UNDER THIS AGREEMENT AND MADE AVAILABLE TO LICENSEE. IN NO EVENT SHALL LICENSOR BE LIABLE FOR ANY LOST DATA OR FOR ANY INDIRECT, INCIDENTAL, SPECIAL, CONSEQUENTIAL, EXEMPLARY OR PUNITIVE DAMAGES ARISING OUT OF OR RELATING TO THE SOFTWARE, DOCUMENTATION OR THE SERVICES PROVIDED HEREUNDER, EVEN IF LICENSOR HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES, INCLUDING WITHOUT LIMITATION DAMAGES FROM INTERRUPTION OF BUSINESS, LOSS OF PROFITS OR BUSINESS OPPORTUNITIES, LOSS OF USE OF SOFTWARE, LOSS OF DATA, COST OF RECREATING DATA, COST OF CAPITAL, COST OF ANY SUBSTITUTE SOFTWARE, OR LOSSES CAUSED BY DELAY, OR OTHERWISE FOR ANY CLAIM AGAINST LICENSEE BY ANY OTHER PARTY. THE MAXIMUM LIABILITY OF LICENSOR FOR DAMAGES TO LICENSEE FOR ANY AND ALL CAUSES WHATSOEVER, AND CUSTOMER'S MAXIMUM REMEDY, REGARDLESS OF THE FORM OF ACTION, WHETHER IN CONTRACT OR IN TORT, INCLUDING NEGLIGENCE, SHALL BE LIMITED TO REIMBURSEMENT OF THE TOTAL AMOUNT PAID BY LICENSEE TO LICENSOR UNDER THIS AGREEMENT.

8. Miscellaneous

Neither this Agreement nor the license granted hereunder may be assigned or sublicensed by Licensee. This Agreement shall be governed by and construed and enforced in accordance with the laws of the State of Texas and the copyright laws of the United States of America. THIS AGREEMENT CONSTITUTES THE COMPLETE AND EXCLUSIVE STATEMENT OF THE AGREEMENT BETWEEN THE PARTIES, IN THE SUBJECT MATTER HEREOF.
